New Accounts

To open an account, please complete and send via email, fax or postal mail:

- (1) Account Information Form
- (2) California Resale Certificate
- (3) A copy of your resale license / seller's permit and business license
- (4) Initial Order (use Wholesale Order Form)
- (5) Credit Card On File Authorization Form (optional)

The California Resale Certificate is required whether or not you operate in California. If your company does not have a California Seller's Permit because you do not operate in California, please note this on the California Resale Certificate.

Orders and minimums

Orders may be faxed, emailed or mailed. Please use the Wholesale Order Form. \$75 minimum for initial orders, \$30 thereafter. All orders must contain a minimum of 3 of each pattern ordered. Prices are in US dollars and are 50% of suggested retail prices.

Payment Terms

Orders must be pre-paid using one of the following methods:

- check drawn on US bank
- major credit card (Visa, MasterCard, American Express or Discover)
- PayPal

If you would like to keep your credit card number on file, please fill out the Credit Card On File Authorization Form. International shops that would like to pay by credit card must either pay via the secure online Paypal interface or keep a credit card on file. US and Canadian shops may elect to be called for credit card information separately for each order. Checks must be made payable to Cookie A Knitwear Design.

Shipping

All packages will be shipped via USPS Priority mail or USPS Priority International. Shipping cost will be actual USPS rate.

International packages are marked as commercial documents originating in the USA. While most countries do not charge customs duty on incoming American documents, please keep in mind that there may be charge of customs duty or brokerage fee imposed by your government or other entity in your country on items received from the United States. You are responsible for all custom and brokerage fees, duties and taxes that are imposed when these goods are shipped to your country.
